- Eligible entrants:** Entry is only open to QLD residents who are 18 years and over. Entrants under the age of 18 must have parent or legal guardian approval to enter.
- How to Enter:** To enter the Prize Draw, the entrant must visit the word finders in centre near Woolworths and BIG W and complete the entry form available near BIG W with all the words found. The entry must be submitted during the Promotional Period to be deemed eligible.
- Entries permitted:** Entrants can enter an unlimited number of times during the Promotional Period.

1. The entrant agrees and acknowledges that they have read these Conditions of Entry (and Schedule) and that entry into the Promotion is deemed to be acceptance of these Conditions of Entry (and Schedule). Any capitalised terms used in these Conditions of Entry have the meaning given in the Schedule, unless stated otherwise.

2. The Promotion commences on the Start Date and ends on the End Date ("Promotional Period"). Entries are deemed to be received at the time of receipt by the Promoter and not at the time of transmission or deposit by the entrant. Records of the Promoter and its agencies are final and conclusive as to the time of receipt.

4. 19. The Promoter reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). In the event that a winner cannot provide suitable proof as required by the Promoter to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered.
